#### [Extinguishing Media]

Extinguishing Media

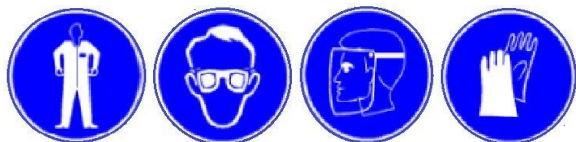
